# 1. Opening, welcome and legality

The Annual General Meeting 2019 was found to be legal and quorum.

# 2. President's report

"PRESIDENT'S REPORT – WGA ANNUAL GENERAL MEETING TANKAVAARA, FINLAND  $8^{TH}$  AUGUST 2019.

Good evening and welcome to all delegates from the various member countries to the Annual General Meeting of the World Gold Panning association

In addition, we welcome our youth representatives, the Japanese delegates, the New Zealand delegates, and our delegate from Denmark as observers to our meeting!

#### 5.2. Summary of the World Championships 2018 in Hodrusa-Hamre, Slovakia

Esko Orava, Chairperson of the Competition Committee gave his report of Slovakian Championships:

"In general, the Championships event in Hodrusa-Hamre was well organized. The competition ran, smoothly, efficiently and the systems used were highly effective.

The spirit and philosophy of the World Gold Panning Association of fair play and sportsmanship prevailed throughout the event.

- Only one rerun!
- One protest was handled
- One disqualification

# Few points to be noted:

- Even though it is not against the rules, the issue of buckets with no seeded gold in the team competitions emerged again. Perhaps it will be considered for adjustment as part of the rules review process we are currently embarking on.
- Quite a common issue again, just not only in Hodrusa-Hamre, was the treatment and maintenance of the practising pools. This matter will constantly be emphasized for correction to future host countries. As the Chairperson of the competition committee he will emphasize compliance to expectations/rules. The matter should also be in the guidelines for future organizers to consider.
- Extremely, well done Slovakia!"

The members of the WGA Board concurred with the sentiments expressed by many member countries on the success of the WGPC 2018 in Slovakia. The WGA Board on behalf of all member countries paid its compliments to the organizing committee!

# 5.3. Needs to change the Competition Rules. Frank Hartmann, Member of the Board

A Working group set up at the AGM 2018, for updating the Competition Rules of WGA is doing its job.

#### 5.3.1 The current progress report by Frank Hartmann was presented at the meeting:

# Rules committee report, by Frank Hartmann:

"I would like to give you a short summary about the work of the Rules committee to explain what we have done in the past and what are the tasks for the future.

After WGC 2017 the WGA Board has received several proposals from Switzerland, from Sweden, from Netherlands and from Finland to improve and to change the Competition Rules.

At Spring Board Meeting 2018 this matter was under discussion and because of the extensiveness of this issue, a working group was set to go through all proposals and to give a suggestion of the changes to the Competition Rules of WGA to the Board until SBM 2019.

As proposed from the Netherlands, **Ruurd van Wijhe** created a new version of the rules by taking the content of the existing "competition rules and guidance "and bringing it into a new order first, then commenting every paragraph and every sentence, where the rules are not distinct enough and including the proposals of the WGA member nations. Then, within the Working Group, every single comment was discussed and priorities were set for the most important changes of the rules.

These topics were discussed with the WGA board during 2019 Spring board meeting. Because of the huge amount of changes in relation to the current issue of the rules, the decision was made not to present the (completely) new version but to make a proposal to change the rules for the most important topics (as given in paragraph 5.3 of the agenda).

During our discussion of the rules some very basic thoughts were made about the organization of World Goldpanning Championships, about the rules and about the penalties:

Our WGA COMPETITION RULES AND GUIDANCE contain a lot of recommendations for organizers of World Goldpanning Championships. But many very important and necessary things for organizing a perfect championship are not written anywhere. So WGA noticed that it would be very helpful to have a document – a guideline for organizers of WGC – to give future organizers every information needed to run a smooth and perfect event. Fortunately, this document has been made up (developed) by former WGA president Arturo Ramella and will be presented later on by himself.

But beside these recommendations we also have a lot of obligations for organizers: recommendations are "nice to have", but obligations are a "must".

What can we do, if organizers don't play by the rules? What if we have stones in the gravel, bigger than 25mm, what if we have lumps of clay in the buckets, etc., What are the consequences? We can't and we don't want to stop the whole event. Should we think about penalties for organizers? Is this an appropriate way to increase the income of WGA?

When we were discussing the rules, we noticed that several rules are not accurate enough, some rules are describing rule violations without setting penalties and several procedures are not even described in the rules.

*I will give you some examples:* 

#### a) Rules that do not seem to be accurate enough.

Touching bucket or pan before starting signal will lead to two minutes penalty. But what about touching the tube or the cap? Some competitors are already holding their tubes between their lips or in a special tube holder around their arm during the starting signal. They do it because they think it's more comfortable for them or because they expect a small advantage in time. But shouldn't all competitors start under equal conditions? In our opinion it should not be allowed to touch the tube or the cap before (at) the starting signal.

#### b) Rules without penalties for rule violations.

If a pan is to be passed between team members it must be washed upside down by the panner in the panning pool before it is passed on. No penalty for a rule violation is given.

No team member is allowed to touch the bucket, pan or sand and gravel of the person who is panning. The others are permitted to prepare to pan. No penalty for a rule violation is given.

What is an appropriate penalty for violation these rules?

#### c) Missing rules

Currently it is not conclusively regulated that a competitor may start in two or more different teams in a category or that the composition of a team may be changed during the competition.

Competitors starting in two different teams may enhance their chance of getting to the next round. This can be an advantage for the competitor and has to be validated as an unsportsmanlike conduct. Disqualifications for the team should be an adequate penalty.

One very fundamental question is: why do we have those different penalties for different rule violations? What were the basic thoughts when the rules, the rule violations and the penalties were defined? When we were discussing the rules we could set up four basic rules for rule violations and penalties, that probably could be valid for every situation:

#### Proposal of basic rules for penalties:

- 1) If the execution of the event is disturbed or delayed: first time yellow card, second time two minutes penalty. If the event had to be proceeded: disqualification (e.g. arriving too late at bibbing area)
- 2) If the rule violation leads to an advantage in panning time: two minutes penalty, e.g. false start, pressing button before capping, two panners in the pool at the same time, etc.
- 3) If the rule violation might have an influence on the number of flakes found: disqualification (in that category) (e.g. taking spilled material back into the pan, and probably: not washing pan up-side down)
- 4) (crude) Unfair behavior with disturbing other competitors: disqualification

Most of the proposal seem to be useful, but...

Do we basically want to start a discussion about the content, about every sentence and every single word in the document? You all know that we don't have the time to do this during our Annual General Meeting. What would be a suitable platform for a discussion? Who should be involved? This is the quandary (dilemma) of our situation.

Or should we better use our rules and guidance as they are and make changes only step by step as we did in the past and as we do today?"

#### 5.3.2 Current amendments of the Competition Rules

At the SBM 2019 was considered that handling of issues, Amendment of the Competition Rules by the Working Group and the" Guidelines for Organizers of World and European Gold panning Championships" by Arturo Ramella, are so extensive that they were combined and handled together.

the Board expressed its appreciation on the work done by the Working Group and Arturo Ramella thus far. The Board engaged with the various proposals raised for consideration. It was agreed that this "project" will be considered "Work in Progress" and consequently proposed changes will be presented incrementally for consideration and adoption.

After extensive discussion the Board proposes few most important changes in the Competition Rules of WGA to be voted for at the AGM:

#### 3.D. The Competition Gold

1. The gold flakes used must be natural alluvial gold flakes and equal to or more than 18 carats. The gold must not be mechanically processed (e.g. hammered). Exception from this rule is only acceptable for host countries that are not allowed to use alluvial gold due to national or local laws.

#### Decision: Accepted unanimously

#### 3.D. The Competition Gold

3. The number of gold flakes for each competitor in a single heat must be the same.

The number of gold flakes between each heat and each round may differ, but in the same qualification round only by 1-2 gold flakes if <u>time comparison</u> between the heats is used.

Local Organizer must inform in advance which system will be used.

The number of gold flakes must be between the following amounts:

- a. All individual competition heats between 5-12.
- *b. All individual competition finals between* 7 –12.
- c. All team competitions between 10 -20.

# Decision: Accepted unanimously

# 4.G. Team Competitions

7. A competitor is allowed to start only in one team in every team category. If the composition of a team has to be changed due to special circumstances (illness, accident, etc.) a competitor may be replaced by another competitor who has not panned in that category. Competitors panning in more than one team in a category will be disqualified together with their teams.

#### Decision: Accepted unanimously

**5.3.3 Former President, Arturo Ramella** has been working with the guidelines" How to help organizers of the Championships to arrange proper competition event".

Arturo Ramella was invited to attend the meeting to briefly present his views of this matter:

During his presentation Arturo Ramella mentioned that "Good Practices Booklet, How to organize a world event." will be available by asking the file on email basis.

After thinking the matter more closely, he prefers to set the latest version on WGA's website so anyone can download it there. The latest version will always be updated on the website.

Note: The Booklet will be uploaded on WGA's website asap!

# 5.3.4 AGM discussed also the Family Category and its rules.

It was noted that for the future of the WGA is important to invest families and especially young people and children. Family Category was considered as a very important part of all Championships events.

Because this is not yet an official category, it gives to future Local Organizers the opportunity to develop the category further.

To inform in advance how this category will be run in the event is essential.

This whole issue of the future of the Family Category was sent to the next Spring Board Meeting to be handled further.

# 6. Bids to host Championship events of the WGA.

# 6.1 Bid to World Gold Panning Championships 2022.

Poland has expressed its interest to host 2022 World Championships.

The representative of Polish Guild of Gold Prospectors Jaroslaw Dudkiewicz has submitted a support letter of the Mayor of Zlotoryja for hosting World Championships 2022 in Zlotoryja, Poland.

The formal application form of WGA to host Championships is also received.

**Delegate of Poland, Jaroslaw Dudkiewicz** briefly presented the bid to host 2022 World Gold Panning Championships in Zotoryja, Poland and welcomed all to participate the event

Decision: Annual General Meeting unanimously granted WGA's Member Nation Poland's association, Polish Guild of Gold Prospectors, Zlotoryja, Poland, right to host and organize 2022 World Gold Panning Championships.

Polish Guild of Gold Prospectors / Norbert Makovski have sent earlier a letter to the Board that because no one of their officials are able to attend Tankavaara 2019 AGM, they want to do a brief presentation of Polish World Gold Panning Championships event at 2020 AGM in Nony Knin, Czech Republic. The Presentation to Competitors takes place in Dawson City, Canada 2021.

# **6.2 Bids to European Gold Panning Championships 2021?**

2021 World Gold Panning Championships takes place in Dawson City, Canada. Because this event is outside of Europe, the European Championships shall be arranged in some European country.

The Board is still waiting for bids to this event.

**President Sanjay Singh** asked the Member Nations' Delegates seriously to consider of making a bid to host European Championships, perhaps even as a joint project of national associations.

For the organizer, interested in to run the event, there is time until next year's Spring Board Meeting (SBM) to leave to the President an application to host the European Championships 2021. Exact time and place of next years SBM is not been decided yet, normally it takes place in May early June in connection to some Member Nation's competition event.

# 6.3 South African support to World Gold Panning Championships 2023

Ms. Sibongile Nkosi, Head of Communications in the Mpumalanga Department of Culture Spirit and Recreation, payed a visit at the meeting and addressed the government's official support to bid for hosting 2023 World Gold Panning Championships in Pilgrims Rest, South Africa.

The Board is waiting for the official application form from the Local Organizer in South Africa.

#### 7. Board Election

The election of new Board Members is not topical this time.

**President Sanjay Singh** noted to the Delegates to consider that next year Secretary's mandate (2 x 3 years period) will be over.

#### 8. Projects

Every year in the budget of the WGA a sum of money is reserved for the projects to support young gold panners.

The SBM 2019 decided that, as the test case, the WGA supports children's event in Tankavaara with the proposed sum of 700  $\epsilon$ . The impact of this programme will be assessed and evaluated.

The Board is waiting for proposals for new projects.

# 8. Youth /Children / family programmes

**Sanjay Singh** 

Based on the letters from **Nicolo Polidori** by the Young People of WGA and **South African Association** the Board meeting talked about the possibility to establish a new **Youth Committee**, Youth representative's right to attend at AGM as the observes, even the possibility of getting the 6<sup>th</sup> member of the board for the youth.

As it was done experimentally last year, the Board agreed the idea to call permanently 2 representatives of Youth of the WGA as observers at the AGM.

The representatives of Youth, chosen to be as the observers at the AGM, were **Luka Hink**, Netherlands and **Robin Hartmann**, Germany.

AGM thoroughly discussed the matter to establish the Youth Committee.

The AGM made a decision, that the Youth Committee will be established, and young people of WGA shall choose the chairperson among them, and after that the President will appoint her/him until the next SBM?

# 9. WGA as an organization.

# **9.1 Registration of WGA as NPO** (Non-Profit Organization?)

The Board agreed with the Principle that some sort of registration will create greater leverage for the association in accessing more resources / partners / sponsorships.

However, there is a need for more information on possibilities regarding relevant organizations and processes to be followed in order to achieve this.

#### 9.2 Permanent address of WGA.

If we are to follow the process of Registering the WGA as a Non-Profit Organization, there will be a need have a Non-private residential address for the organization. In this regard it may be necessary to consider using one of the Member Nation addresses as the address.

#### 9.3 Fund raising and sponsorship for WGA and its programmes.

In order to take a greater contribution to programmes (in particular Youth programmes) of the WGA and for the WGA to be able to give greater assistance to host Nations, it is imperative to open up a discussion on possible areas of income generation.

A decision to open up this discussion to member countries may yield positive results. This will be considered "on going" until some solution will be found.

# The AGM considered that the issues exists according the chapters 9.1, 9.2 and 9.3 above. Some questions were raised up:

How and where to do a registration of the association as NPO, in some Member Nation, USA, EU, globally?

How to get WGA's own bank account, which is currently a private account of the treasurer? Auditing procedure of Financial report?

Permanent address? Taxation?

Or whether it will be better to continue as it is today, as an unofficial community in its current form?

Eventually the Board needs a lot of assistance from Member Nations associations, in legal aspects of these matters, to be able to continue to handle this issue further.

# 9.4 Tokens of appreciation/acknowledgement to

- Outgoing office bearer
- Host nations
- Celebrations of special milestones

The Board meeting concurred that there is a clear need for tokens of appreciation to office bearers who have completed their terms of office. However, what exactly these tokens will be is still up for further discussion.

With regards to celebration of Special Milestones by Host Nations, Host nations are encouraged to ensure that the WGA has this information timeously, preferably when they are making their Bid Presentation.

e.g. This year in Finland, Tankavaara will be celebrating 150 Years of Gold Discovery in Finland, Ivalojoki-river and 70 Years Celebration of Gold Prospectors Association of Finnish Lapland (Member Nation's association of WGA)

The Board asked the attendees at the meeting to consider this matter and to inform of the major celebrations of their own Nation's, hometowns', association's, people's and so on.

#### 10. Other current issues:

No other issues appeared.

# 11. Closure of the Meeting.

**President Sanjay Singh** thanked all the attendees at the AGM as well the Local Organizer and wished all good time at the event and success in the competitions in Tankavaara.

President Sanjay Singh declared the Annual General Meeting 2019 of the World Gold Panning Association closed.
